### 3. How We Use Your Information

We may use your information for the following purposes:

- To respond to your inquiries or requests
- To improve website functionality and user experience
- To send updates or announcements related to our services (if opted in)
- To monitor website traffic and performance



To ensure compliance with applicable laws and regulations

We do **not** sell or rent your personal information to third parties.

### 4. How We Share Information

We may share your information under limited circumstances:

- **Service Providers**: We may work with vendors (e.g., IT or web hosting companies) who assist us in maintaining the website and services. These vendors are bound by confidentiality agreements.
- **Legal Requirements**: We may disclose your information if required by law, legal process, or government request.
- **Emergency Situations**: To protect the health, safety, or rights of others if reasonably necessary.
